Approximately 16 residents, council members, Police Chief Reed Mernick from City of Woodbury as well as Chief Glenn Scheetz, and PBA representatives gave their thoughts regarding a possible police shared service agreement. The possibility of putting this issue to a referendum was also suggested and discussed again.

Chief Reed Mernick of City of Woodbury indicated he was not aware of other towns going to a referendum for approval of a shared service agreement. He offered his assistance to the committee and council with their decision making.

Most residents wanted to keep the police department in town and not merge and suggested Council seek other methods of cost containment. Many indicated that the dollars saved, spread out over all residents, would not make up for the loss of our police officers. Some residents indicated that in this economy they would be hard pressed to pay additional borough taxes. There were those who agreed that council should check the options of merging with another town as long as the safety of the residents was not in jeopardy. Council President John Howard assured all that a check list had been established by the committee on the criteria required to assure proper coverage in the borough for police protection. Mayor Lombardo indicated he spoke to other town mayors and will also reach out to their residents concerning how police shared services has worked for them.

Mayor and Committee members assured the audience at this time they are still only gathering information. They will research the proposals carefully and not compromise public safety.
