Council President John Howard requested to open the public portion of the meeting with a statement to clear up rumors about a planned "police merger". He gave the audience a time line of the series of events to explain to all those in attendance (Wenonah residents and police officers, residents and police officers from other towns, and PBA officials) that the committee, in sending out letters and meeting with other towns, was only fact finding, not making or accepting any offers.

Open to Public (Cont'd)

The meeting was then opened to public comment. Approx.31 people spoke, some more than once: 12 police/PBA, 18 residents 1 from out of town. They expressed their opinions regarding this issue. Some gave personal stories regarding the positive influence that Wenonah police officers have on Wenonah's youth as well as how Wenonah's officers have gone out of their way to assist them during times of personal problems.

Many also indicated a concern regarding response time if we merge with another town; that Wenonah would always be the "other town" and not get the immediate response to calls we currently experience. Also, that Wenonah would lose its identity with a police merger. Most wanted to keep the police department in town and not merge; rather Council should seek other methods of cost containment. Many indicated that the dollars saved, spread out over all residents, would not make up for the loss of our police officers. Those who spoke and wanted council to check the options of merging with another town were in the minority.
