The following report summarizes the status of the various projects authorized by the Mayor and Borough Council:

I. CONSTRUCTION PROJECTS:

2014 BOROUGH ROAD PROGRAM & 2013 NJDOT MUNICIPAL AID PROJECT

- 1. Our office has obtained approval of a Thickness Waiver from the NJDOT conditioned upon the Borough not being eligible for reimbursement for the costs of the Asphalt Sampling and Core Testing. Please note that the Contractor has agreed to reimburse the Borough for these costs, as well as the costs for all work performed pursuant to the preparation of the Thickness Waiver Request.
- 2. In order to document the reimbursement from the Contractor, our office will prepare a Change Order to modify the Final Contract amount for approval at the next regularly scheduled Council Meeting on February 26th.
- 3. Additional adjustments to the final contract amount, including the reconciliation of all as-built quantities, will be reflected in the Final NJDOT Change Order which shall be submitted to the Borough for approval along with the Final Payment Request at the next regularly scheduled Council Meeting on February 26th.

- 2. The previously submitted NJDEP Application for a Letter of Interpretation (LOI) has been deemed administratively complete by the NJDEP and is currently under review.

- 5. Bid advertisement will be scheduled pending the receipt of the necessary NJDEP approvals.

BOROUGH WATER TOWER AND WELLS

- 1. The Flow Meter at Well #1 remains temporarily out of service. The Public Works Department is planning for the installation of a new flow meter. In the meantime, meter readings are now being calculated based upon the run time for the pumps, at an output of 300 gpm.
- 2. It is our understanding that the Borough Public Works Department is coordinating the inspection of the Water Tower's interior ladder and harness with the Contractor.
- Our office has assembled and submitted detailed information to assist Council in formulating a decision as to the payment of AC Shultes \$19,040 invoice for repairs that were performed to Well #2. We will be available at the Council Meeting to answer any questions relative thereto.

PORTABLE GENERATOR FOR WATER SYSTEM FACILITIES

- 1. Our office has researched possible funding opportunities for a Portable Emergency Generator and based upon our research, we were unable to locate a viable funding source from the County, the NJDEP, and/or the New Jersey Office of Emergency Management.
- 2. It should be noted that the pool of eligible applicants for funding under the New Jersey Hazard Mitigation Grant Program (HMGP) was based on Letters of Intents (LOIs)

- that were submitted to the Office of Emergency Management in December 2012 and January 2013.
- 3. Accordingly, it is our recommendation that considerations be made to supplement the Project with additional funds in order to provide for the necessary budget.

DELAWARE RIVER BASIN COMMISSION (DRBC) WATER SYSTEM AUDIT

1. Our office will work with the Borough on the completion of the 2014 Water System Audit which is due March 31, 2015.

WATER METER UPGRADES

1. No Change Since Last Report.

NJDEP WATER ALLOCATION

- 1. The Borough's total water usage for the Year 2014 is approximately 62.31 million gallons, which is approximately 10 million gallons below the Annual Allocation Limit of 72.07 million gallons.
- 2. The renewal of the Borough's NJDEP Water Allocation Permit will be performed in conjunction with the Water Allocation Permit required for new Well #3.

BOROUGH WATER SYSTEM GIS MAPPING

1. It has come to our attention that the NJDEP will soon be requiring that additional information be provided in the Water System GIS Maps, i.e. locations of valves and fire hydrants, etc. Please note that this work may be a pre-requisite for our proposed NJDEP Well Permit Applications.

GIS MAPPING PROJECT

1. Our office met with the Shade Tree Commission to discuss the details of a proposal for a pilot GIS Project to be performed in 2015.
