PLEASE BE ADVISED THAT CONSTRUCTION ON **LENAPE TRAIL FROM MOHAWK DRIVE TO MOHAWK DRIVE** WILL BEGIN ON OR ABOUT AUGUST 12th 2022. THE CONSTRUCTION WORKING HOURS WILL BE FROM 7:00 AM TO 4:30 PM. IN THE EVENT OF INCLEMENT WEATHER, CONSTRUCTION ACTIVITIES WILL BE POSTPONED UNTIL THE FOLLOWING DAY. ALL WORK SHOULD BE COMPLETED WITHIN (60) DAYS FROM THE START OF CONSTRUCTION.

DURING CONSTRUCTION, PLEASE FOLLOW POSTED DETOUR SIGNS. WE WILL MAINTAIN ACCESS TO YOUR HOME/BUSINESS AT ALL TIMES, HOWEVER, IT MAY BE NECESSARY TO CLOSE YOUR DRIVEWAY FOR A SHORT PERIOD OF TIME DURING CONSTRUCTION. DURING WORKING HOURS, WE ASK FOR YOUR COOPERATION BY NOT PARKING VEHICLES ON THE STREET.

WE ALSO ASK THAT YOU MARK OUT AND LOCATE, ALL EXISTING SPRINKLER SYSTEM COMPONENTS AND UNDERGROUND PIPING LOCATED WITHIN 12 FEET OF EXISTING CURBS, WHILE EXISTIG LANDSCAPING IMROVEMENTS AND IRRIGATION SYSTEMS THAT ARE SUFFICIENTLY MARKED OUT AND ARE NOT IN CONFLICT WITH THE PROPOSED CONSTRUCTION WILL BE MAINTAINED BY US TO THE GREATEST EXTENT POSSIBLE.

ANY LANDSCAPING AND/OR IRRIGATION IMPROVEMENT WHICH ARE LOCATED WITHIN 5 FEET OF EXISTING CURBS AND/OR WITHIN 2 FEET OF EXISTING AND/OR PROPOSED SIDEWALKS WILL MOST LIKELY BE IN CONFLICT WITH THE PROPOSED CONSTRUCTION AND THEREFORE, ARE SUBJECT TO REMOVAL BY US.

WE WILL NOT BE RESPONSIBLE FOR THE REPLACEMENT AND/OR REPAIR OF ANY EXISTING IMPROVEMENTS THAT ARE LOCATED WITHIN 12 FEET OF EXISTING CURBS, AS THIS AREA IS DEFINED AS THE BOROUGH'S CLEAR ZONE.
